2. Written statement describing the project that outlines the overall project intent and scope of work.
3. Review fees: \$2,125.00 per application

For items 4 and 5, provide (1) 24"x36" set to scale, (1) 11"x17" set to scale, and one digital copy in PDF format.

4. Certified topographical boundary survey of the existing site prepared by a licensed surveyor at an approved scale with two foot contours which includes the following:
 - Survey must reflect current conditions
 - Existing grades referenced to USGS elevations
 - Existing utility locations
 - Existing vegetation; size and botanical name noted
 - Building footprint(s) of all existing structures and improvements on site
 - Drainage facilities
 - On and off-site circulation and parking
 - Existing physical encroachments on and off-site
 - All structures within 20' of the subject property; include structure height
5. Site plan identifying all surrounding uses within 300 feet.
6. Current Title Report – dated within 30 days of submittal.
7. An electronic Excel spreadsheet with property owner, Summit County Assessor Parcel Number, and mailing address for properties within 300 feet, measured from the property line.
