Topic 1: Call Meeting to Order (5:01p.m)

Topic 2: Public Comment: Any Items Not on the Agenda

Not at this time.

Topic 3: Approve Minutes from the October meeting

Molly motioned to approve the December meeting's minutes, seconded by Jess. Motion passed unanimously.

Topic 4: Staff and Board Communications

City Updates

Chris reported that the Land Management Code (LMC) amendment regarding height requirements for bus shelters has passed. The code now allows elements no more than 4 feet above the top of the shelter, which could create opportunities for future public art installations should the board wish to pursue them.

Public Body Recruitment update, two members terms are concluding Sam and Pam, Terri's spot is vacant and Kara and Molly's term ends June 2026. Molly and Kara are eligible to apply for a second full term.

The Public Body Recruitment is from March 11-April 8, there will be a subcommittee created for interviews and the recommendation will go to Council late May and early June.

Pam is interested in staying on board. Stephanie will follow up.

SCPAAB/Arts Council Update

Jocelyn shared that SCPAAB is finalizing the contract for the Rail Trail project in Coalville. She noted there has been some complexity, as the Rail Trail is owned by the state while the artwork will be owned by the county. The project is anticipated to be completed by May.

Jocelyn also shared that Summit County has been working on the former Skullcandy Building, which has been renamed the Peak Building (Public Engagement at Kimball). There is a \$100,000 allocation for public art as part of the Percent-for-Art program, and SCPAAB will be meeting with relevant departments to discuss the direction of the public art piece.

Jocelyn added that the Arts Council presented the Arts and Culture Master Plan in January, which received unanimous support from both City Council and County Council along with the adoption of a resolution in support of the plan. She noted the document is comprehensive, approximately 124 pages—and includes valuable information related to funding and planning. The plan outlines a 10-year framework and includes an implementation dashboard to track both short-term and long-term strategies. Jocelyn emphasized that the plan is particularly timely as the community considers economic vitality and diversification in a tourism industry that can be impacted by conditions outside of local control, such as weather. She noted that arts and culture can play an important role in helping fill that gap and that there are several initiatives related to public art.

Jocelyn stated she will be coordinating with Stephanie and Chris to take a deeper dive into the plan over the next six months.

Kara suggested setting aside time during future meetings to review the Arts and Culture Master Plan so that PAAB members can better understand the document. She noted this could potentially occur during meetings that do not include deliberation items.

Other Staff or Board Communications

Pam shared that she participated in the selection committee for the 2026 Historic Preservation Award, this artwork will be tentatively revealed sometime in May as May is Historic Preservation Month.

Stephanie has been working on the Public Art Story Map. She has coordinated time with Tanzi, Digital Communications Coordinator, to capture over 100 artworks to update the story map. Stephanie will send the board a link to the updated Public Art Story Map.
